


Why this?



Significance of Family Disputes Mediation in Legal Careers

- Conversely, mediation agreements that incorporate aspirational language about co-parental communication and child adjustment are **associated with less re-litigation, demonstrating mediation's effectiveness in fostering long-term stability for families.**
- The sheer volume of these disputes and their profound societal impact, particularly on children, positions family mediation not merely as a legal service but as a critical social intervention. This elevates the career path beyond conventional legal practice to one of significant social responsibility and impact, appealing to individuals seeking purpose-driven professional roles.
- Expertise in family mediation is increasingly crucial for aspiring legal professionals. Mediation is often a mandatory step for cases involving family disputes and the equitable distribution of assets in many jurisdictions. This makes proficiency in family mediation a non-negotiable skill for those aspiring to practice family law.
- Participation in a specialized family mediation competition cultivates essential skills vital for success in this field. Participants hone their Alternative Dispute Resolution (ADR) capabilities, facilitate networking with professionals, and gain opportunities to interact with experienced judges and established mediators.



Chapter - I

- **Short Title and Commencement:** These rules shall be known as the 'Family Harmony Mediation Challenge Rules & Procedure, 2025'. They will officially come into force from the date of their publication on MediateGuru's official website.
- **Definitions:** The existing definitions from the VIMC rules have been adapted to explicitly include the context of family disputes where applicable. For instance, the "Competition" refers specifically to the "Family Harmony" Mediation Challenge 2025. The "Mediation Problem" refers to case scenarios specifically designed around family disputes, encompassing issues such as divorce, child custody, child support, spousal support, division of assets and debts, and post-divorce disputes.
- **Interpretation:** The Organizing Committee retains the right to interpret these rules as deemed appropriate to ensure fairness and equality among participants and organizers. Any interpretation made by the Committee regarding the application of these Rules & Procedure shall be conclusive and final, binding all stakeholders and participants.

Chapter - II

- **Eligibility:** To be eligible for participation, students must be registered as full-time or part-time law students in the academic year 2025-2026. Additionally, students who graduated in 2025, provided their graduation occurred no more than six months prior to the commencement of the competition, are also eligible to participate.

Chapter – II

- **Application Process:** The Organizing Committee will communicate the acceptance of registration via email. Participating teams are required to accurately fill in all necessary details in the provisional registration google form. A confirmation of participation email will be sent by the Organizing Committee upon verification of the entire process. Any additional charges incurred by the team during the payment process are to be borne by the team.
- **Withdrawal Procedure:** Any team wishing to withdraw from the competition may do so by sending a detailed email to the Organizing Committee. As stipulated, if a withdrawal occurs after the registration fee has been paid, the fee will not be refunded to the team.
- The registration fees for the "Family Harmony" Mediation Challenge 2025 are structured;
 - For Indian Teams - Rs. 3500/-
 - For European Teams - £70/-
 - For other International Teams - \$70/-

Note: The fee is inclusive of an exhaustive training session exclusively for the participants.

Chapter – III

- **Format of the Competition:** The competition is structured into Qualifying Rounds and Advanced Rounds. The Qualifying Rounds consist of two Preliminary Rounds, while the Advanced Rounds comprise two knock-out stages: the Semi-Final Round and the Final Round.



Chapter – III

- **Composition of Team:** Each participating team will consist of three members: a Client, a Counsel, and a Mediator. In instances where a team has only two participants, one participant will assume the role of Mediator, and the other will act as the Advocate, representing the client's interests.
- **Language:** The official and sole language for all aspects of the competition, including submissions and sessions, shall be English.
- **Structure of the Competition:** The competition will span four days, commencing from October 23rd to October 26th, 2025. In the Preliminary Rounds, each Mediating Pair will serve once as the Responding Party and once as the Requesting Party in their respective sessions. The top four Mediating Pairs and Mediators from the Preliminary Rounds will advance to the Semi-Final Round. Subsequently, the top two Mediating Pairs and Mediators from the Semi-Final Round (from each room) will qualify for the Final Round. In the event of a tie in scores between two Mediating Pairs or Mediators in any round, the tie-breaker will be determined by "Mediation Advocacy" for the Mediating Pair and "Qualities of a Good Mediator" for the Mediator.
- **Time Period:** The allocated time periods for each round are as follows: Preliminary Round 1 and 2 will each be 45 minutes; the Semi-Final Round will be 60 minutes; and the Final Round will be 90 minutes.
- **Mediation Problem:** The Mediation Problem(s) for all rounds will be distributed via Notice Board three days prior to the respective round. These problems will be exclusively focused on complex and realistic family dispute scenarios, specifically designed to challenge participants in areas such as child custody, property division in divorce, spousal support, and inter-generational family conflicts.

- **Confidential Information:** Participants will receive confidential information 40 minutes prior to their allotted time slot. Strict adherence to confidentiality is paramount; participants are expressly prohibited from disclosing confidential information to any other participant throughout the competition, whether before or after their round. Any such disclosure will lead to immediate disqualification from the competition without any scope for appeal.
- **Scope of Interpretation:** Participants are required to restrict their interpretation of the problem to reasonable conclusions and are not permitted to create additional facts.
- **General Rules of the Competition:**
 - Each mediation session will involve two teams and two mediators competing in a Conference Room before the Judges.
 - A session typically comprises six individuals: two Mediators and two Mediating Pairs (each pair consisting of a client and a counsel).
 - The Mediator(s) are tasked with guiding the disputing parties towards a settlement.
 - The time period for each session is prescribed in the rules, and the Mediator(s) have the discretion to adopt a common code of procedure, provided it does not contravene the general rules of the competition.
 - No extra time will be granted under any circumstances. Regarding private caucuses and conferences, the Mediator(s) have sole discretion to call for these, though they must call for at least one to facilitate the mediation process.
 - A caucus is a private meeting between one party and the Mediator(s), while a conference is a joint session involving both parties and a Mediator.



- When a caucus is called, the other party must leave the room.
 - During a conference, both parties must be present.
 - While Mediator(s) may call for both, disputing parties may also request a caucus.
 - Participants are permitted to carry and use their own prepared notes and to make additional notes during the session.
 - However, using electronic devices into the Conference Room during a session is strictly prohibited, and no audio or videotaping of Mediation Sessions is allowed.
- **Clarifications:** Teams may submit queries regarding the mediation problem within the prescribed time frame. Responses to these clarifications are at the drafter's discretion, and clarifications will not be accepted after the specified deadline.
 - **Dress Code:** The dress code for the competition shall be business formals, reflecting the professional decorum expected in family law and mediation proceedings.
 - **Awards and Prizes:** The Mediator and the Mediating Pair who achieve the highest scores (evaluated separately) in the Final Round will be recognized as the "Best Mediator" and "Best Mediating Pair," respectively, and will be awarded a Certificate of Merit. The Runner-Up Mediator and Runner-Up Mediating Pair will also receive a Certificate of Merit. Certificates of Merit and Ranks will be awarded to the Top 5 Mediators and Mediating Pairs. The "Best Team" will be determined based on the highest average marks obtained in the Preliminary Round and will receive a certificate of merit. Every participating team will be awarded a "Certificate of Participation".

Chapter – IV

- **Code of Conduct Applicable to Participants:** All teams are bound to adhere to the code of conduct and rules established by the organizing committee. Any behavior demonstrating indiscipline towards Judges, the Organizing Committee, staff members, or student volunteers will be dealt with strictly and may result in immediate disqualification from the competition without appeal. Any attempt to contact the framer(s) of the problem(s) or the panel of Judges prior to the competition will also lead to immediate disqualification without appeal.




Chapter – IV

- **Anonymity of Teams:** Following registration and receipt of acknowledgment, teams will be assigned a unique Team Code, which will serve as their sole identifier throughout the competition. No participating team is permitted to reveal their identity in any other form during the competition. Violation of this rule will incur severe penalties or disqualification, as determined by the Organizing Committee, whose decision in this regard shall be final and binding without appeal.
- **Scouting Policy:** No member of any team will be permitted to observe the proceedings in any Conference Room where their team is not actively participating, for as long as their team remains in the competition. Any violation of this rule will lead to strict actions, which may include, but are not limited to, the expulsion of the offending team from the competition.
- **Walkover:** If any team fails to appear at their allotted time, the opposing team will be granted a walkover, and their scores from the previous or upcoming round will be doubled to compensate.

Chapter – IV

- **Power to Make Amendments, Modifications or Revocations:** The Organizing Committee reserves the power to amend, modify, or revoke the provisions of these rules, either partially or wholly, subject to considerations of feasibility, transparency, and the smooth functioning of the competition. Any such amendment or modification will come into force upon its official notification and will be deemed an integral part of these rules.



Chapter – V

- **Savings Clause:** *Nothing within these Rules & Procedure shall prejudice any right that a participant would have possessed prior to the enactment of these Rules & Procedure. Furthermore, the Organizing Committee or MediateGuru shall not be held responsible for any actions of the participants that violate the present Rules & Procedure, whether occurring before or during the course of the competition.*

The ability to resolve sensitive family matters confidentially and efficiently ⁴ is highly valued by clients and legal firms. This competition not only develops essential skills but also signals to potential employers a participant's specialized interest and foundational competence in a high-demand, emotionally complex legal area. By participating in a specialized family mediation competition, students proactively demonstrate their interest and foundational competence in a niche that is both high-volume and high-stakes (concerning emotional well-being and children's welfare). This specialization makes them more attractive to family law firms, ADR centers, and related organizations, as it reduces the training burden for employers and indicates a genuine passion for the field. It provides a tangible credential that differentiates them from general law graduates, offering a competitive advantage beyond general legal qualifications.
